## **Senior Lawyer**

- Represent the company in court in conjunction with the Head of Legal and/or external lawyers.
- Work together with the other colleagues in the Legal and Regulatory Department and colleagues from all other Departments of the Company, as well as colleagues from Vodafone Group or Other VF Group Operating Companies and external partners.
- Active participation and contribution to the assigned Vodafone Group Law Practice Group.
- Representation of Vodafone Albania in the respective Practice Group and Point of Contact for Vodafone Albania.
